# **PREREQUISITES**

To be allowed to take the Final Exam, which has a qualifying value for the practice of medical profession, it is mandatory to have acquired 347 ECTS following the successful completion of all the educational activities provided in the Study Plan, as well as those related to internship and seminar activities

### **LEARNING OBJECTIVES**

The student, upon completion of the study course, should have the knowledge, theoretical-practical and technical-operational skills specific to the Medical Profession. In addition, the student should know how to use scientific research methods in writing the final paper (dissertation).

# **LEARNING OUTCOMES**

# **Knowledge and understanding**

The student is expected to acquire the theoretical-practical and technical-operational knowledge and skills expected for the practice of the Medical Profession; as well as knowledge of scientific research methods.

## Applying knowledge and understanding

The student will be able to apply the skills provided by the professional profile of the general practitioner, according to the best scientific evidence and in compliance with ethical rules. He/she will also know how to use scientific research methods for the writing of his/her final dissertation.

#### **Communication skills**

The student will have to demonstrate the ability to use appropriate scientific terminology, both to communicate adequately in different health care settings and with various interlocutors (health professionals, caregivers, patients, etc.) and in the final dissertation.

#### Making judgements

The student will be able to apply the knowledge acquired appropriately in the training programme to different health care contexts, critically interpreting the data collected for the final dissertation.

#### Learning skills

The student will have acquired learning skills and methods suitable for the deepening and improvement of his/her skills in the medical field, also through the consultation of scientific



literature.

## TEACHING METHODS AND METHODS OF LEARNING ASSESSMENT

The discussion of the dissertation consists of the presentation of the thesis in the presence of the Member of the Graduation Committee. The Graduation Committee gives the final exam a score between 0 and 14 points as follows:

- 0 to 4 points for the type of research;
- up to 1 point for the quality of the presentation;
- up to 1 point for the mastery of the topic;
- up to 1 points for the ability in discussion;
- 3 points for students in line with the course schedule;
- up to 2 points for the number of *cum laude* obtained in the exams;
- up to 1 point for the participation in international exchange programs;
- 1 point for the activity of student representatives carried out in University's organs.

# **SUPPORT ACTIVITIES**

The supervisor supports the student in the writing of the final dissertation.
